1. The Stover Fair Board reserves the right to refuse any vendor.
2. Rules and regulations apply to all vendors. Failure to comply with rules and regulations will result in immediate removal from the show.
3. Your booth space will be assigned upon receipt of payment. **Booth spaces will not be held without payment.** Payment will not be accepted at the door.
4. The Stover Fair Board prohibits the sale of guns, pellet guns, commercially manufactured knives, or related items.
5. Booth spaces will be assigned up on receipt of application/contract.
6. All vendors must be unloaded by 11:00 AM Friday morning and ready for sales by 1:00 PM. On Friday, June 18, the doors will open promptly at 1:00 PM and close at 7:00 PM. On Saturday, June 19, the doors will open at 9:00 AM and close at 4:00 PM.
7. Vendors may take down their booths any time after 4:00 PM, Saturday, June 19, but not before 4:00 PM.
8. Tables must be covered to the floor. Please make sure your display is neat and clean.
9. Make sure your display is contained within the designated area.
10. If you asked for electricity, please bring an extension cord.
11. The following will not be sold during the event: eggs or live animals or silly string.
12. DIRECT SALES: We will only allow one representative per company. The first representative to send in the payment with the application form will be the one to have the booth space. ONLY payment will reserve a space.
13. Each vendor is responsible to comply with the State of Missouri Tax Regulations.
14. The Representatives planning the event are not responsible for any lost, stolen, or damaged items throughout the event.
